**INVITATION FOR EXPRESSION OF INTEREST (EOI) OR TENDER**

It is notified for general information that the Government of Sikkim hereby invites Expression of Interest (EOI) or Tender from the interested and eligible Firms or Proprietorship or Companies or Partnership firms registered under the law, for selection and appointment as Distributor or Marketing Agent for marketing and sale of 16 (sixteen) Online Weekly Lotteries in 02 (two sets) i.e. 08 draws each per day to be conducted by the State of Sikkim as per the Lotteries (Regulation) Act, 1998 (No.17 of 1998) the Lotteries (Regulation) Rules, 2010, the Sikkim Online Network Lottery Rules, 2001.

- (1) The Tender Document containing the prescribed application form and detailed terms and conditions of the tender shall be issued only to the eligible Firms/Proprietorship /Companies/Partnership firms registered under the law.
- (2) The Tender Document may be obtained from the Office of the Director, Sikkim State Lotteries, Finance Department, Government of Sikkim, Deorali, Gangtok during office hour w.e.f. 17-03-2020 on payment of a non-refundable amount of ` 2.00 lakhs (Rupees Two lakhs) only as application/tender document fee by Demand Draft / Pay Order to be drawn on any Scheduled/Nationalized Bank having its branch at Gangtok in favour of the Director, Sikkim State Lotteries, Finance Department, Government of Sikkim, Deorali, Gangtok.
- (3) The Tender documents should be accompanied by a refundable Earnest Money Deposit (EMD) of ` 2.50 Crores (Rupees Two Crores and Fifty Lakhs) only by Demand Draft / Pay Order to be drawn on any Scheduled/Nationalized Bank having its branch at Gangtok in favour of the Director, Sikkim State Lotteries, Government of Sikkim, Gangtok.
- (4) The prescribed Application Forms (APPLICATION FORM – TECHNICAL BID and APPLICATION FORM – FINANCIAL BID) duly filled in along with all the requisite certificates/documents should be submitted in sealed cover(s) to the Office of the Director, Sikkim State Lotteries on or before 12.00 Noon of 17-04-2020. The tender documents received after 12.00 Noon of 17-04-2020 shall not be entertained.
- (5) The Bids (Technical and Financial) of the sealed tender documents shall be opened by the Tender Selection Committee on 17-04-2020 from 01:30 pm onwards in the Conference Hall, Directorate of Sikkim State Lotteries in the presence of bidders or their representatives who may wish to be present.
- (6) Interested bidders willing to be present in the opening of the bid documents should obtain a proper authorization letter duly issued by the authorized signatory of the Company or Firm or Body or Individual or other legal entities and to be submitted before the Tender Selection

Committee at the time of opening of the Tender. The authorized persons of not more than two from each tenderer will be allowed to be present at the time of opening of the bid document.

- (7) The Tenderer must be capable of commencing the operations with effect from the date stipulated in the tender document.
- (8) The tenure of distributorship shall be for a period of 01 (One) year from the date of commencement of the first draw or till such period of the implementation of the amended Lottery Rules as notified by the Ministry of Home Affairs, whichever is earlier.
- (9) The State Government may deem fit and proper to specify any other terms and conditions to be incorporated in the tender document.
- (10) The Directorate of Sikkim State Lotteries reserves the right to add, delete or modify the tender document.
- (11) The State Government reserves the right to reject all or any of the tender(s) or cancel the tender process without assigning any reasons thereof.
- (12) The Directorate of Sikkim State Lotteries may be contacted for any queries or clarification during the office hour.
