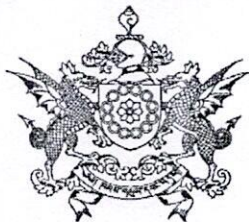

In exercise of the powers conferred under Clause 3(3) of the Lotteries (Regulation) Rules, 2010, and Rule 4(2)(b) of the Sikkim State Lottery (Regulation) Rules 2023, the Governor of Sikkim is pleased to notify the Sikkim State Weekly Paper Lottery Scheme as detail given below:-

1. Name of the Bumper Lottery Scheme : **DEAR GANESH CHATURTHI BUMPER LOTTERY**
2. Maximum Retail Price of the Lottery Ticket : Rs. 500/- (per ticket)
3. Maximum No. of tickets : 5 Lakhs, Numbering: 100 000 to 599 999
4. Face Value of Lottery Ticket : Tickets to be issued to the distributors shall be at the Face Value. The Discount will be 45.91% on MRP.
5. Gross value of maximum tickets : Rs. 25,00,00,000/- (Twenty Five Crore Rupees only)

10. The amount offered as prize money : Rs. 8,04,35,000/-
11. Periodicity and Time of Draw : 08:00 P.M onwards
Place where the draw shall be conducted : Directorate of Sikkim State Lotteries, Deorali, Gangtok - 737102.
13. Procedure of conducting the draw :
The draw shall be conducted in a mechanical method, based on random technology and it shall be visibly transparent to the viewers in the presence of the judges who are appointed by the Government of Sikkim.
14. Procedure of drawing the Prize winning Tickets :
The winning numbers shall be drawn as per the Prize Structure (Sl.No.9). It is done by pressing the numeric control by the officials of the Directorate of Sikkim State Lotteries after which the winning numbers are displayed in the draw machine.
15. Procedure for prize payments :
 - a) Prize Money for taxable prize(s) shall be paid by the Directorate of Sikkim State Lotteries, Gangtok.
 - b) Only the sold tickets will be eligible for prizes under any prize rank.
 - c) Prize Money for non-taxable prizes(s) (Below Rs. 10,000/-) shall be directly paid by the Agent/Seller. If a winner, wins prize money exceeding ₹ 10,000/-, from multiple tickets, he/she must inform the retailers/sellers while making his/her claim. In such an event, the said prize money should be claimed from the Government in the prescribed claim form. The retailer/seller in no circumstances disburse the prize money exceeding ₹ 10,000/- to a particular winner.
16. Description about Sl.No.3 :
The number of tickets printed shall be subject to increase or decrease, depending on the market conditions, and it shall be approved by the Director of Sikkim State Lotteries from time to time, keeping in view the Maximum No. of tickets in this Scheme.
17. Delivery of tickets :
 1. The tickets will be handed over to the distributor via Delivery Note issued by the Directorate.
 2. The distributor shall report the details of unsold tickets prior to each draw to the Directorate.
18. Sale of tickets :
Tickets will be sold in the State of West Bengal, Punjab, Sikkim, Maharashtra, Meghalaya and Nagaland. It is to be noted that no tickets shall be sold after the commencement of the draw or reporting of unsold by the distributors/retailers. The unsold lottery tickets shall be returned back to the Directorate of Sikkim State Lotteries for adjustment.
